

NEW DEVELOPMENTS 2024 WITH RESPECT TO THE REMOVAL OF POSIDONIA REMAINS ON BEACHES.

In the specific case of the beaches of Denia, the different stretches of beaches taking as a reference the Catalogue of Beaches established by Decree 58/2018, of May 4, of the Consell, approving the Territorial Action Plan of the green infrastructure of the coast of the Valencian Community (PATIVEL) are cataloged:

LES DEVESES:

Natural of special protection N1 - Area adjacent to Riu Molinell

Protected Natural N2 - From the area adjacent to Riu Molinell to C/ Riu Grande

ALMADRAVA:

Urban with restrictions U2 - From C/ Riu Grande to C/ Riu de Gallinera

Urban U1 - From C/ Riu de Gallinera to C/ Riu Girona

ELS MOLINS:

Protected Natural N2 - From Riu Girona to C/ Llac Tiberiades

Natural of special protection N1 - From C/ Llac Tiberiades to Punta Molins (Rte Cova del Mero).

LES BOVETES AND LES MARINES:

Urban with restrictions U2 - From Punta Molins to Regatxo C/ Mussola (Bassetes).

LES MARINES AND PUNTA RASET:

Protected natural N2 - From Regatxo C/ Mussola (Bassetes) to the beginning of the port.

MARINETA CASSSIANA:

Urban U1 - From the beginning of the port to C / Escorpi (Rotes).

ROTES:

Natural protected N2 - From C/ Escorpi (Rotes) to Ctra. Provincial Barranco del Monyo 144 aprox. by Rte Ca Nano)

Natural of special protection N1 - From crtra. Provincial Barranco del Monyo 144 approx. (Rte Ca Nano) to the end of the municipality.

WHICH ARE THE BEACHES WHERE THE REMOVAL OF POSIDONIA IS NOT AUTHORIZED?

- Beaches classified as natural, regardless of their level: N0, N1, N2 or N3.
- When the urban beach is in a marked situation of retreat from the coastline.
- Beaches with a width of less than 10 m.
- Exceptionally, in certain beaches N2 or N3, that correspond to stretches of small dimensions (coves of less than 200 m of length; or beaches of similar length of artificial nature between breakwaters) and with high tourist frequentation, it will be able to be authorized, in the period between May 1 to September 30

IN THE CASE OF DÉNIA, posidonia may NOT be removed from the following beaches:

- LES ROTES BEACH (The whole area).
- LES RASET BEACH (All the area)
- LES MARINES BEACH: Including the area Albaranes to Blay Beach
- ELS MOLINS:
 - N1: From Punta Molins to Restaurant Estanyó
 - N2: From Estanyó Restaurant to Riu Girona
- LES DEVESES:
 - N2: From c/ Riu Grande (Rte Almar) to C/ Riu Tapiada
 - N1: From C/ Riu Tapiada to Riu Molinell

PERIOD OF POSIDONIA REMOVAL:

- Urban beaches: period from March 15 to October 31.
 - Natural beaches (in exceptional cases to be determined): from May 1 to September 30.
- It may not be carried out during the rest of the year.
